### Distinguishing the Difference

“Christ has redeemed us from the curse of the law, having become a curse for us (for it is written, “Cursed is everyone who hangs on a tree”)” (Galatians 3:13)

“And he showed me a pure river of water of life, clear as crystal proceeding from the throne of God and of the Lamb. In the middle of its street, and on either side of the river, was the tree of life, which bore twelve fruits, each tree yielding its fruit every month. The leaves of the tree were for the healing of the nations. And there shall be no more curse, but the throne of God and of the Lamb shall be in it, and His servants shall serve Him.” (Revelation 22:1-3)

### Are these verses contradictory?

Did Jesus take the curse upon himself on one hand- but it's not complete on the other? Revelation 22 is referring to the Millennial reign of Christ when the full execution of the verdict of the cross will be in full effect. It will not happen until a new heaven and new earth are in place. The legal verdict was rendered at the cross “It is finished” meaning Christ accomplished His purpose. However, humanity is still enslaved to what controls them. We will not be completely free from the curse and the ramifications therein until the new bodies are given. However, we can judicially placate what has already been granted in part. The full freedom is afforded later (Romans 8:18-25). **+STUDY THIS+**

### REVIEW OF OUR PRIMARY TEXT

“I, even I, am He who blots out your transgressions for My own sake; and I will remember your sins no more. Remind me. Let's argue the case together. Recount the facts, so that you may be vindicated. Your first father sinned, and your mediators have rebelled against me. Therefore I will profane the princes of the sanctuary; I will give Jacob to the curse, and Israel to reproaches.” (Isaiah 43:25-28)

When God gave Israel to reproaches and Jacob to the curse because the first father's sin and the mediator's transgressions testify against the people of God. Given to the reproaches against the nation means that the legal claim the devil has to the nation due to their sin, iniquity, and trespasses are warranted. “Jacob” must present his case before the Lord. And because the church is grafted into the Abrahamic Covenant, we **are able** to present our case before the Lord in order to see the claims and accusations of the devil silenced and revoked. This can be so for a nation, people, or on a personal level.

“If you walk in My ways, and if you will keep My command, then **you shall also judge My house**, and likewise **have charge of My courts**” (Zechariah 3:10)

The “Branch” prophesied after this verse in Zechariah is referring to Jesus, the Messiah. The Messiah shall come and give us the legal standing in order to be able to intercede on behalf of those in need.

We must first come before the Lord and allow the blood of Jesus to cleanse and wash us thoroughly. Forgive ourself and others who sin against us. Then partner with God to assist those in bondage and captivity (enslaved) to sin, dealing with generational iniquity and lawlessness.

### • PRAYER

Lord, as I come before Your Courts, I thank you for the privilege and honor of partnering with You in Your covenant purposes. You have chosen us as your vessel, through the blood of Your Son Jesus, to intercede for the saints.

I ask that because of the blood of Jesus on my life that every word rising up against me in accusation would now be revoked and annulled by the voice of Jesus's testimony on our behalf.

Allow me to now take my place in Your Court in order to present a case before You.

Lord, as I come before You, by faith I step into the heavenly dimension called the Courts of Heaven. I enter through the blood of Messiah, Jesus, that was shed for me. According to Hebrews 10:19, I enter the holiest place through and by this blood. I thank You that because of the blood of the Lamb, I am worthy to stand in this place and present my cases before You.

- **SUBMIT YOURSELF**

As I stand before Your Courts, Lord, I yield and submit myself to who You are. According to James 4:7, I am to submit myself to You as God. The result will be the enemy will flee when I resist. Therefore, I come and humbly yield my being and all that I am to You. I request that according to Romans 12:1-2 I would be an acceptable sacrifice to You, holy and submitted. I ask that I might manifest the good, acceptable, and perfect will of God in and through my life. Search me, O God, according to Your divine inspection and let me be holy and pleasing unto You. Let anything in me that is against You be removed and extracted from my life.

- **PRESENT YOUR CASE**

Lord, I now bring my case before You. I request and petition before this Court and make my request from the books and/or scrolls that are in heaven according to Daniel 7:10. From these books, I present my prophetic destiny and purpose that was written about me before time began. I also ask that anything resisting my destiny and purpose ordained by You would be judged as illegal and unrighteous. I remind the Courts that the fulfillment of the purpose of God is dependent on my gaining the destiny intended for me. Therefore, I ask that all that is written in my book would now begin to come to pass with nothing able to testify against it.

- **ANSWERING THE ADVERSARY**

Every case against me from my own life and/or bloodline, I now ask that the blood of Jesus would speak for me according to Hebrews 12:24. Let every sin, transgression, deceit, and iniquity be cleansed away from me. I ask that anything the devil is using to legally deny me all that is ordained for me would now be judged as illegal and unrighteous. I repent for any and all claims against me. I ask that Jesus would testify for me according to 1 John 2:1-2 as my intercessor and propitiation. Let it be recorded that my faith and confidence is in Jesus and His blood. Therefore, I request that every tongue speaking against me would be stopped in Jesus' Name. Lord, I also repent for any and all covenants made with demons or demon powers through sacrifices, offerings, vows, announcements, and agreements with witchcraft. I ask that every altar in the spirit world be torn down, the voice of offerings be silenced, and the openings to the gates of Hell closed. Let all evil lose function against me. I also give back anything these powers would claim I have gained through them (power demon example). I want nothing from satan's kingdom. I only want that which comes from Jesus and what is written about me in my book.

- **MAKE YOUR REQUEST**

Lord, I now stand before You justified through the blood and atoning work of Jesus in me. I request that everything written in my book will now be brought to reality. Make any other requests here.

- **RECEIVE**

Lord, as I continue to stand before Your Courts, I receive that which is now being released by verdicts, decisions, and the rulings of Your Courts. I thank You for Your love, grace, and mercy and for giving Your Son's life as a free gift to those who would receive it. I thank you that the power of the devil is now revoked. His legal right to harass, resist, and hinder my destiny and purpose in Your kingdom is now annulled and dismissed. Every accusation he used against me is now silenced and that I will come into that which You have purposed for my life. I also ask that because You said the thief, when caught, must repay seven fold what was stolen, that the thief would have to repay what he stole from me as well (Proverbs 6:31). My Your full restoration come as a result of these legalities being removed and renounced and made manifest by the power of Jesus Christ in me through Your Holy Spirit.

Thank you Lord for allowing me to stand in this Holy Place. Thank You for allowing me to bring my petition before you Lord. May this petition be recorded in heaven and allowed to be granted while on earth.
